MINUTES Board of Trustees Executive Session – February 20, 2014

The Board of Trustees of the Illinois Teachers' Retirement System met in executive session on February 20, 2014 at the Springfield office of the Illinois Teachers' Retirement System, 2815 West Washington Street.
