## Minutes

A draft of the October 28, 2015 minutes of the diversity committee meeting was sent to the committee members for review. On a motion by Bob Lyons, seconded by Dan Winter, and by unanimous voice vote, the minutes were approved as printed.

Gina Larkin, Chief Human Resources Officer, provided an overview of TRS's staff diversity hiring and recruitment efforts. Ten percent of the TRS workforce are minority. TRS has filed its Affirmative Action Plan.

Jana Bergschneider, Chief Financial Officer, provided an overview of TRS's procurement policies. Article I of the Pension Code requires pension funds to adopt goals to improve utilization of businesses that are owned by minorities, females, and persons with disabilities. TRS has met its FY 16 minority utilization goal of 5% of the applicable TRS vendor contracts and uses the State of Illinois Enterprise system to identify vendors who qualify. Separate utilization goals are stated in the TRS investment policy.
