MINUTES Investment Committee August 12, 2021

The Investment Committee meeting of the Illinois Teachers' Retirement System was held on August 12, 2021 at the Chicago Marriott Naperville, 1801 N Naper Boulevard, Naperville, IL. Chairman Miller called the meeting to order at 8:47 a.m. A quorum was present. TRS PORTFOLIO

<u>Investment Portfolio Summary</u>

Stan Rupnik, Executive Director and Chief Investment Officer, provided the final May 2021 investment manager charts. Documentation is on file.

Minority Utilization Report

(remote presentation)

Jose Gonzalez, Investment Officer – Diverse & Emerging Managers, provided preliminary data as of June 30, 2021 on the utilization of minority-owned brokers and minority-owned investment managers within the TRS investment portfolio. The total TRS portfolio represents 24.68%, which is 3.68% over the TRS fiscal year 2021 utilization goal of 21%. Documentation is on file. Mr. Gonzalez reported that brokerage and asset management goals for fiscal year 2022 goals will be re-assessed and voted on at the October Board meeting.

Diversity Measurement RFP

(remote presentation)

Representatives of Lenox Park Solutions provided a presentation on the development of a standardized scoring tool for Diversity, Equity & Inclusion (DEI). Documentation is on file. TRS Staff provided an overview of the firm and due diligence that was conducted. A motion was made by Trustee Hirshman, seconded by Trustee Hunt, to select Lenox Park Solutions to provide a standardized DEI measurement and scoring solution within the System's investment program. The motion passed by unanimous voice vote.

Cashflow Summary

Stan Rupnik provided a cash flow summary to fund the System's cash requirements. Documentation is on file.

Investment Activity Report

Stan Rupnik provided an overview of investment activity by asset class completed by the System's investment staff for the period May 29 through July 22, 2021. Documentation is on file.

Global Income Asset Class – Coriolis, L.P.

At the June investment committee meeting, Aksia presented an investment opportunity for a commitment to a private credit mandate. Following the presentation, the committee approved a motion to recommend to the Board to commit \$250 million to TRS Coriolis, Limited Partnership. A final vote will be taken at the August Board meeting since the June meeting was postponed due to the declaration of Juneteeth as a state holiday.

The meeting recessed at 10:00 a.m. and reconvened at 10:15 a.m.

Investment Performance

Tony Johnson of RVK provided an overview of trending pension topics and capital markets as of June 30, 2021. Documentation is on file. Stan Rupnik provided a preliminary overview of the June 30, 2021 asset class performance. Preliminary assets under management totaled \$62.9 billion as of June 30, 2021.

Asset Allocation

Becky Gratsinger and Tony Johnson of RVK provided an overview of TRS's asset allocation process including capital market assumptions, supplemental liquidity analysis, and asset allocation modeling. Documentation is on file. RVK and TRS Staff proposed recommendations to the long term and interim asset allocation targets to provide guidance and structure to the investment program. A motion was made by Trustee Strand, seconded by Trustee Hirshman, that the committee recommend to the Board to adjust the System's long term and interim asset allocation targets and to rebalance range targets, as presented, effective July 1, 2021. The motion passed by unanimous voice vote.
