Stan Rupnik provided an overview of investment activity by asset class completed by the System's investment staff from September 30, 2022 through November 15, 2022. Documentation is on file.

MWBE Utilization Report

Stan Rupnik provided preliminary data as of September 30, 2022 on the utilization of minority-owned brokers and minority-owned investment managers within the TRS investment portfolio. TRS exceeded its brokerage goals by 4.5% for international equity, and 4.0% for global fixed income. TRS missed its brokerage goal by 2.3% for US equity. As of September 30, 2022, MWBE assets as a percent of total plan were 28.42%, which is 6.42% over the TRS fiscal year 2023 utilization goal of 22.0%. Documentation is on file.

Investment Performance & Pension Trends

Ian Bray and Tony Johnson of RVK, Inc. provided an overview of the final September 30, 2022 investment performance report, including trending pension topics and capital markets. Topics included tightening of monetary policy by global central banks, persistent inflation and the simultaneous market corrections in both public equity and fixed income markets over the first nine months of 2022.
