MWBE Utilization Report

Jose Gonzalez, Senior Investment Officer – Diverse & Emerging Managers, provided preliminary data as of March 31, 2023 on the utilization of minority-owned brokers and minority-owned investment managers within the TRS investment portfolio. TRS exceeded its brokerage goals by 23.4% for US equity, 5.1% for international equity, and 5.1% for global fixed income. As of March 31, 2023, MWBE assets as a percent of total plan were 29.31%, which is 7.31% over the TRS fiscal year 2023 utilization goal of 22.0%. Documentation is on file.

General Investment Consultant RFP

The contract with the System's general investment consultant, RVK, expires in June of 2023. Staff issued a Request for Proposal on January 13, 2023, and following a review of all responses and semi-finalist interviews, staff selected Meketa and RVK as finalists for the Investment Committee to interview. Bob Jiroutek provided a background of the search process and the due diligence that was performed. Meketa provided a presentation to the committee, followed by a presentation from RVK. The firms' presentation books are on file. Following a robust discussion on the merits of each firm, a motion was made by Trustee Hunt, and seconded by Trustee Blomquist, that the committee recommend to the Board to engage RVK as TRS's general consultant for a five-year period. The motion passed by unanimous voice vote. On a motion by Trustee Sanders, seconded by Trustee Hirshman, a motion was made to issue an RFI for a provider to conduct a replication asset allocation study in calendar year 2024. The motion passed by unanimous voice vote.
