MWBE Utilization Report

Jose Gonzalez, Senior Investment Officer – Diverse & Emerging Managers, provided preliminary data as of June 30, 2023, on the utilization of minority-owned brokers and minority-owned investment managers within the TRS investment portfolio. TRS exceeded its brokerage goals by 20.9% for US equity, 0.6% for international equity, and 6.4% for global fixed income. As of June 30, 2023, MWBE assets as a percent of total plan were 29.22%, which is 7.22% over the TRS fiscal year 2023 utilization goal of 22%. Documentation is on file.

Private Credit Consultant Search

The contract with the System's current private credit investment consultant, Aksia, expires on September 30, 2023. Staff issued a Request for Proposal on November 10, 2022, and following a review of all responses and semi-finalist interviews, staff selected Aksia and Albourne as finalists for the Investment Committee to interview. Stan Rupnik provided a background of the search process and the due diligence that was performed. Aksia provided a presentation to the committee, followed by a presentation from Albourne. The firms' presentation books are on file. Following a discussion on the merits of each firm, a motion was made by Trustee Goetz, and seconded by Trustee Pfeiffer, that the committee recommend to the Board to engage Aksia as TRS's general private credit consultant not to exceed a five-year period. The motion passed by unanimous voice vote.

Real Estate/Real Assets Tactical Plan

Tim Hays, Senior Investment Officer – Real Estate, Dakin Sanert, Investment Officer – Real Estate, and Jeremy Goldberg, Matthew Moreno, and Justin Thibault of StepStone presented the FY2024 real estate/real assets tactical plan. The plan includes a review of FY2023 initiatives, FY2024 initiatives, real estate and real asset characteristics, objectives, risk/returns, allocation targets, portfolio initiatives, and a portfolio pacing plan analysis. Documentation is on file. A motion was made by Trustee Peronto, seconded by Trustee Goetz, that the committee recommend to the Board to approve the FY2024 Real Estate/Real Assets tactical plan, as presented.
