# L Kurowski Administrative Review Hearing

A hearing was held on TRS member Lynda Kurowski's appeal of a staff determination on her request for additional service credit. A court reporter was present and took a verbatim transcript of the open portions of the hearing.

Carolyn Clifford, Hearing Officer, provided an overview of the administrative review process and admitted into evidence the documentation submitted by the parties for consideration of Kurowski's claim. Documentation is on file.

#### **Executive Session**

A motion was made by Trustee Jazo-Harris, seconded by Trustee Mena, that the Committee enter into executive session to discuss matters as authorized and permitted under the following exceptions set forth by the Open Meetings Act: evidence or testimony presented in open hearing, or in closed hearing where specifically authorized by law, to a quasi-adjudicative body as defined in this Act, provided that the body prepares and makes available for public inspection a written decision setting forth its determinative reasoning [5 ILCS 120/2(c)(4)].

Roll call resulted in affirmative voice votes from Hirshman, Jazo-Harris, and Mena.

Roll call resulted in affirmative voice votes from Hirshman, Jazo-Harris, and Mena.
