Diversity Report

MWBE Utilization Report

Jose Gonzalez, Senior Investment Officer – Diverse & Emerging Managers, provided preliminary data as of June 30, 2025, on the utilization of minority-owned brokers and minority-owned investment managers within the TRS investment portfolio. TRS exceeded its brokerage goals by 19.4% for US equity. TRS missed its brokerage goal by 5.2% for international equity and 6.3% for global fixed income. As of June 30, 2025, MWBE assets as a percent of total plan were 29.30%, which is 6.30% over the TRS fiscal year 2025 utilization goal of 23%. Documentation is on file.
