Diversity Report and FY2026 Aspirational Goals

Jose Gonzalez, Senior Investment Officer – Diverse & Emerging Managers, provided final data as of June 30, 2025, on the utilization of MWBE brokers and investment managers within the TRS investment portfolio, as required by Illinois statute. TRS met or exceeded its aspirational goals for brokerage in all categories except for international equity, which was short by 0.5%. TRS exceeded its MWBE investment manager aspirational goal. Documentation is on file.

TRS staff presented the System's aspirational MWBE utilization goals for minority brokerage and investment management for fiscal year 2026, in accordance with Illinois statute. Documentation is on file. A motion was made by Trustee Goetz, seconded by Trustee Sanders, that the Committee recommend to the Board to approve the fiscal year 2026 aspirational MWBE utilization goals, as presented.

- Maintaining the aspirational goal for utilization of MWBE asset managers of 23%.
- Maintaining the Domestic Equity MWBE brokerage aspirational utilization goal of 40%.
- Maintaining the International Equity MWBE brokerage aspirational utilization goal of 17%.
- Maintaining the Global Income MWBE trading aspirational utilization goal of 17%.
- Maintaining the existing investment management fee aspirational goal range of 8.0 11.5% of total fees paid.

The above goals will be included in the TRS Investment Policy, Section 20: Improving Access to the TRS Investment Process. The motion passed by unanimous voice vote.
