## Employer Participation Agreements

---

**Unless a TRS employer has formally adopted the SSP Participation Agreement, their TRS employees will not be eligible to register for the SSP.**

TRS is required to offer the SSP to its active members but can only do so if employers officially adopt the SSP Participation Agreement. Beginning later in 2022, state law requires TRS to automatically enroll all new TRS members in the SSP.
