Occasionally we may also include "tips and tricks" and "coming soon" items as well.

What's New

Pav-Period Edits

The following pay-period edits have been modified or created to improve validation of pay-period data:

- New edit ER4060 has been added to prevent employers from reporting an End Date that is prior to the reported Pay Period Begin Date with Days Paid or Post-Retirement Hours reported. (TRS Reference #101125)
- **ER1036 Updated** The criteria has been updated to invoke if the future date is greater than 10 days from the current date. (*TRS Reference #140105*)
- New edit **ER7033** has been added to prevent employers from reporting new members with missing address information. (*TRS Reference #140106*)
- **ER5062 Updated** The criteria has been updated to only include the Cumulative Total Flexible Benefit Plan (FB) Payment Reason earnings for the current report value and any past report values. Future dated reports with values are excluded from the Cumulative total. (TRS Reference #144558)
- Two new informational edits have been added to Contribution Reporting.
 - **ER5071** has been added to give employers advanced warning when a member is approaching the 401(a)(17) limit.
 - **ER5072** has been added to give employers advanced warning when a member is approaching the Tier 2 limit.
- Existing edits **ER5033** and **ER5034** have been updated to only include prior records in the Cumulative Earnings total. (*TRS Reference #101121*)

- New edit ER6038 has been added to invoke when entering Adjustments and Days Paid is greater than zero and has associated total earnings of less than 0.01. (TRS Reference #130752)
- New edit **ER4063** has been added to invoke when Days Paid or Post-Retirement Hours are reported for a member for a pay period that is outside of the corresponding fiscal year. (TRS *Reference #147273)*
- New edit **ER6037** has been added to invoke when Unpaid Leave of Absence (LA) Payment Reason is reported with 0 Days Paid, as Days Paid must be reported for a member on a Leave of Absence. (TRS Reference #147791)

Resolved Issues

The issue regarding the Past Due and Upcoming Notice that is distributed on the 5th of each month via email has been resolved. These notices will now include FY23-24 items that are still past due.
