#### **What's New**

## **Pay-Period Edits**

The following pay-period edits have been modified or created to improve validation of pay-period data:

- Updated ER4013 and ER4060 to add additional criteria that will trigger the edit if the Employment End Date provided is not within the Fiscal Year provided on the record. (TRS Reference #146586 & 149948)
- New edit ER4064 has been added to prevent employers from reporting Extra-duty Employment for retired members. (TRS Reference #147272)
- Edit ER4065 was added to trigger a warning when the employer is potentially reporting a duplicate pay period (on SSP reports only). (TRS Reference #147735)
- ER6039 has been added as a new edit to prevent employers from reporting a Sick Leave value > 999.9.

- On the Report Totals screen, the Federally-funded Earnings section has been updated to read as follows:

Federally Funded Earnings Select a Fiscal Year, Grant Type and enter the Dollar Amount. If you don't see your Grant Type as an option, select "Other."

• ER6028 has been updated to always require Post-retirement Hours when reporting Post-Retirement work (Contribution Category '99'). (TRS Reference #147046)

### **Improvements**

Employer Portal users will be allowed to void reports that have been stuck at an Edit Ready status, Load Batch Running or Edit Batch Running for a minimum of 1 hour. (TRS Reference # 130282)
