The TRS Supplemental Savings Plan

The TRS Supplemental Savings Plan (SSP) is a 457(b) savings plan for TRS members administered by Voya Financial. Eligible active members can use the SSP to save extra money that will help them in retirement to supplement their existing TRS pensions. Voya is one of the largest providers of retirement solutions in the country and has vast experience administering these types of plans in other states. Enrolled SSP participants will make their first payroll contributions after March 1, 2022.

Active Tier 1 and Tier 2 members who are full-time or part-time contractual employees are eligible to enroll in the SSP if their employer has formally agreed to participate in the SSP. [View a list of TRS employers that have agreed to participate in the SSP.](#)

The SSP will not replace the existing pension for active Tier 1 and Tier 2 members. It is completely optional. Retired and inactive members are not eligible for the SSP.
