### The TRS Supplemental Savings Plan

The SSP is a 457(b) retirement savings plan administered by Voya Financial of New York. Members can use the SSP to save extra money that will help them supplement their existing TRS pensions in retirement. Voya is one of the largest providers of retirement solutions in the country and has vast experience administering these types of plans in other states.

The SSP will not replace the existing pension for Tier 1 and Tier 2 members. It is completely optional for all eligible active members. Retired and inactive members are not eligible for the SSP.

- Eligible TRS members whose employers have formally agreed to participate in the SSP can begin to sign up for the SSP **on January 10, 2022**.
- Enrolled SSP participants will make their first payroll contributions to their new 457(b) retirement savings accounts **after March 1, 2022**.
